## How Did the Fund Perform Last Year?

MSCI Emerging Markets Dividend Growers ETF (the "Fund") seeks investment results, before fees and expenses, that track the performance of the MSCI Emerging Markets Dividend Masters Index (the "Index"). The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. An overweight to Chinese equities drove underperformance relative to emerging market equities. For the year ended May 31, 2024, the Fund had a total return of -1.49%. The Fund invests in financial instruments that the Advisor believes, in combination, should track the performance of the Index. For the same period, the Index had a total return of -0.51% and a volatility of 11.90%. Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of the Fund's index, and other miscellaneous factors.
